ASSIGNMENT OF TRADEMARKS

WHEREAS, Hanger Orthopedic Group, Inc., having its principal place of business at 7700 Old Georgetown Road, Bethesda, Maryland 20814 (hereinafter referred to as "ASSIGNOR"), is the owner of the trademarks and the record owner of U.S. Trademark Registration No. 2,042,961 for the trademark OPNET and U.S. Trademark Registration No. 1,911,834 for the mark HANGER ORTHOPEDIC GROUP INC. (stylized) (hereinafter referred to as the "TRADEMARKS"); and

WHEREAS, Hanger Prosthetics & Orthotics, Inc., a Delaware corporation, having an address of 7700 Old Georgetown Road, Bethesda, Maryland 20814 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring all of the rights, title and interest of ASSIGNOR in, to and under the TRADEMARKS, together with the goodwill of the business associated with the TRADEMARKS;

NOW THEREFORE, in consideration of good and valuable consideration from ASSIGNEE to ASSIGNOR, the sufficiency and receipt of which is hereby acknowledged, ASSIGNOR confirms the transfer and hereby transfers and assigns to ASSIGNEE, the entire right, title and interest in and to the TRADEMARKS, together with the goodwill of the business associated with the TRADEMARKS and all trademark registrations therefor; and


ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns, all claims for damages by reason of past infringement of the TRADEMARKS, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives; and

ASSIGNOR, further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country foreign to the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARKS and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument; and

ASSIGNOR, further agrees to execute such addition documents as may be required in countries foreign to the United States, to record ASSIGNEE as the owner of the TRADEMARKS and registrations and applications herein assigned.
