## ASSIGNMENT OF TRADEMARKS

WHEREAS, Southern Prosthetics & Supply, Inc., having its principal place of business at 7700 Old Georgetown Road, Bethesda, Maryland 20814 (hereinafter referred to as "ASSIGNOR"), is the owner of the trademark and the record owner of Trademark Registration No. 1,412,186 for the trademark ORTHO-MOLD (hereinafter referred to as the "TRADEMARK"); and


ASSIGNOR does also hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns, all claims for damages by reason of past infringement of the TRADEMARK, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives; and

ASSIGNOR, further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any country foreign to the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARK and title thereto as the property of the ASSIGNEE, its successors, legal representatives and assigns in accordance with the terms of this instrument; and

ASSIGNOR, further agrees to execute such addition documents as may be required in countries foreign to the United States, to record ASSIGNEE as the owner of the TRADEMARK and registrations and applications herein assigned.
