

## ASSIGNMENT OF TRADEMARK

WHEREAS, Assignor filed an application with the U.S. Patent and Trademark Office on April 24, 1998, which application has been assigned serial number 75/474153, and is currently pending, and;

WHEREAS, Assignee has acquired the entire business or portion thereof to which the mark pertains as required by 15 USC §1060;

NOW THEREFORE, in consideration of LegaLink's purchase of the company, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee, its successors and assigns, all rights, title and interest in and to the service mark, **COURT REPORTERS WORLDWIDE and Design**, and the goodwill of the business of Assignor associated herewith.

The assignment made herein shall be a worldwide assignment, and shall not be limited to any particular geographic area.

Assignor warrants that it knows of no use by others of this or any other similar service mark in connection with court reporting referral services or related services.

Assignor warrants, covenants and agrees that Assignor is the lawful owner of the service mark, that it has not assigned any rights in the service mark to any other party, that the service mark is free and clear from all encumbrances, liens, conditional sales contracts, security interests, or charges and, to Assignor's knowledge, is free from any and all claims of any persons, firms or corporations whatsoever, and that Assignor shall warrant and defend unto Assignee, its successors and assigns, the warranties and covenants set forth herein.


The assignment by Assignor to Assignee of the service mark described herein includes an assignment to Assignee of any and all rights Assignor has to sue on its behalf for any losses, damages, liabilities, costs or expenses relating to infringements by third parties on the service mark occurring prior to the date hereof.

Assignor agrees that it will no longer use the service mark unless given exclusive permission by Assignee through a written License Agreement by and between Assignor and Assignee.


