





The new lending limit should be calculated by using data from the last Call Report of the individual banks filed prior to consummating the marger, as adjusted for the combination. The resulting bank will then file a new Call Report and begin calculating its legal lending limit according to 12 C.F.R. § 32.4(a) at the end of the quarter following consummation of the merger.
