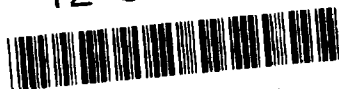

## TRADEMARK ASSIGNMENT


THIS AGREEMENT is effective as of December 11, 1998.
