
Assignor also assigns unto Assignee any rights to register the trademark listed in Exhibit A worldwide.



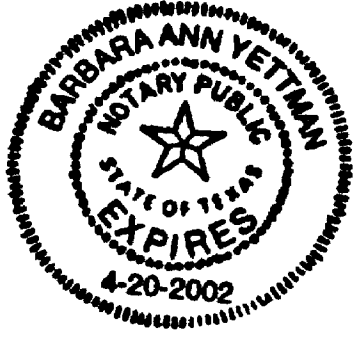
