WHEREAS ASSIGNOR desires to assign said marks to Assignee;



Registrations and Applications for said marks, and all rights at common law in the marks; and Assignor further assigns, transfers, sells and conveys to Assignee, its successors, legal representatives and assigns, the right to apply for, register, renew, protect, defend and enforce any and all rights to the said trademarks including the right to sue for past infringement, the right to enforce any and all trademark rights of Assignor and causes of action therefor, presently known or unknown and inuring to Assignee, and the right to recover all claims for damages or for compensation for past infringement arising out of any cause of action, whether presently known, unknown, accrued or to accrue.

ASSIGNOR further agrees to cooperate fully with Assignee (at no cost to Assignor and without further consideration to Assignor) in connection with perfecting the transfer of all rights to and vesting of full and complete title in Assignee, enforcing and defending the rights transferred, and executing any and all instruments deemed by Assignee to be necessary or desirable to implement and accomplish the transfer, enforcement and/or defense of the rights granted by Assignor hereunder.

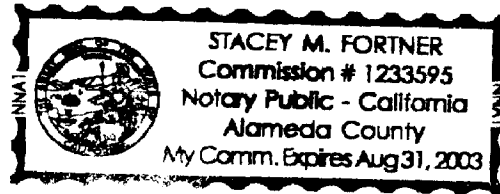
