## ASSIGNMENT OF TRADEMARK

ASSIGNOR, further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the TRADEMARKS and title thereto as the property of the ASSIGNEE. its successors, legal representatives and assigns in accordance with the terms of this instrument; and

ASSIGNOR, further agrees to execute such addition documents as may be required, to record ASSIGNEE as the owner of the TRADEMARKS herein assigned.
