TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment"), dated as of the 20th day of May, 1999, is given by The Farm Journal Corporation, a Delaware corporation ("Assignor"), in favor of Professional Farmers of America, Inc., an Iowa corporation ("Assignee").

Pursuant to that certain Asset Purchase Agreement dated April 16, 1999 (the "Agreement"), between Assignor and Data Broadcasting Corporation, a Delaware corporation ("DBC"), Assignor acquired from DBC the trademarks and service marks set forth on Schedule I attached hereto and made a part hereof (the "Marks") and the registration and applications therefor listed in Schedule I hereto, together with the goodwill symbolized by the Marks and the portion of DBC's business relating to the Marks (the "Business"). Assignor desires to assign, and Assignee desires to acquire, the Marks, the registration and applications listed in Schedule I hereto, the goodwill symbolized by the Marks, and the Business, as acquired by Assignor pursuant to the Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor hereby assigns to Assignee the entire right, title and interest in and to the Marks, the registration and applications listed in Schedule I hereto, the goodwill symbolized by the Marks, and the Business.

This Assignment includes all legal rights associated with such Marks and the United States registration and applications therefor, including but not limited to (i) the right to sue for past and future infringement of such Marks, (ii) the right to file affidavits of continuing use and/or incontestability in connection with the registration listed in Schedule I hereto and in connection with any registrations that may be issued on the applications listed in Schedule I hereto, and (iii) the right to seek renewal of the registration listed in Schedule I hereto and any registrations that may be issued on the applications listed in Schedule I hereto.

Assignor hereby agrees to, and shall, execute and deliver such further instruments of transfer and conveyance and take such action and deliver such other documents, certifications and further assurances as may reasonably be required to effect and record, where necessary, the transfer and conveyance of the foregoing, and Assignor hereby agrees to, and shall, fully cooperate with Assignee in furtherance of the same.
