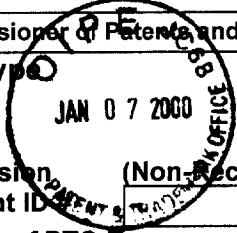



RESTATED CERTIFICATE OF INCORPORATION

(Pursuant to Section 242 of the Delaware General Corporation Law)

The undersigned, being the duly elected Chief Executive Officer and Secretary of LIVE Entertainment Inc., a corporation duly organized and existing under the Delaware General Corporation Law ("DGCL"), in accordance with the provisions of Section 103 thereof, DO HEREBY CERTIFY that:

I. The name of the corporation is LIVE Entertainment Inc. (hereinafter called the "Corporation").

II. The Restated Certificate of Incorporation of the Corporation is hereby amended by striking out Article FIRST thereof and by substituting in lieu thereof the following new Article FIRST:

FIRST: The name of the Corporation is Artisan Entertainment Inc.

III. The amendment of the Restated Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Sections 228 and 242 of the DGCL by unanimous written consent of the Board of Directors and the sole stockholder of the Corporation.
