TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and entered into as of the 22nd day of December, 1999, by and between Respiroics Georgia, Inc., 1255 Kennestone Circle, Marietta, Georgia 30066, a Georgia corporation ("Assignor"), and Matria Healthcare, Inc., 1850 Parkway Place, Marietta, Georgia 30067, a Delaware corporation ("Assignee").

WITNESSETH

WHEREAS, Assignor is the owner of all right, title and interest in and to the mark SYSTEM 37 as well as Registration No. 1,576,235 therefor (collectively, the "Mark"); and

WHEREAS, Assignee and Assignor desire to enter into this Assignment to effect the transfer of the Mark;

NOW, THEREFORE, for and in consideration of the premises and the mutual promises hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:
