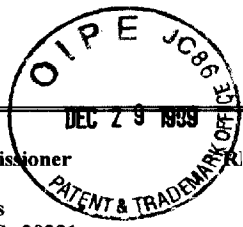


CONFIRMATION ASSIGNMENT
