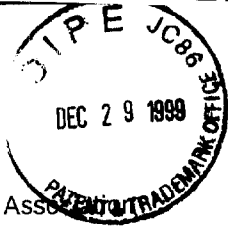

**FIRST:** That the Board of Directors of the corporation, by written consent of the directors, filed with the minutes of the Board, adopted a resolution proposing and declaring advisable the following amendment to the Restated Certificate of Incorporation of the corporation:

**RESOLVED**, the Restated Certificate of Incorporation of PTN Publishing Company be amended by changing Article I, so that amended said Article shall be and read as follows:
