

- 2. The Amended and Restated Articles of Incorporation of the Corporation, filed 9/28 1999 shall be amended as set forth in this Certificate of Amendment.
- 3. Article 1 of the Amended and Restated Articles of Incorporation is amended to read in its entirety as follows:
  - "1. The name of the Corporation is Andalé.com, Inc."
- 4. Pursuant to the Unanimous Written Consent of the Board of Directors dated September 20, 1999, this Certificate of Amendment was approved and adopted.
