TERMINATION OF A SECURITY INTEREST IN TRADEMARKS

WHEREAS, Chiquita Processed Foods, L.L.C. ("Chiquita") has granted a security interest in all of Chiquita's trademarks, including without limitation, those identified on the attached Exhibit A, pursuant to a certain Trademark Security Agreement dated as of February 26, 1999 ("Trademark Security Agreement") in favor of Congress Financial Corporation (Central) ("Congress");

WHEREAS, Congress filed the Trademark Security Agreement in the trademark registers of the U.S. Patent and Trademark Office at (i) Reel 1865 Frame 0916 on March 5, 1999 and (ii) Reel 001935 Frame 0159 on July 26, 1999, to evidence Chiquita's assignment to Congress of its rights under the Trademark Security Agreement with respect to Chiquita's trademarks; and

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Congress hereby desires to cancel and terminate the Trademark Security Agreement, declare the same null and void, of no further force and effect, and further cancels Congress' entire interest in Chiquita's trademarks described in the Trademark Security Agreement.
