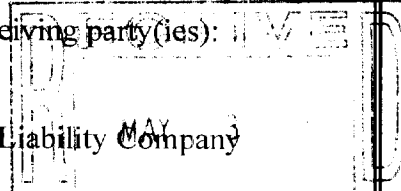

CERTIFICATE OF CONVERSION
