

ASSIGNMENT AGREEMENT

THIS ASSIGNMENT AGREEMENT (this "Agreement") is made and entered into, effective as of this __ day of January, 2000, by and between Saitek Limited, a Hong Kong limited liability company having offices at 5/F1 Llandro Centre, 72 Hoi Yuen Road, Kwun Tong, Hong Kong ("Saitek") and Garry Kasparov ("Kasparov"), a resident of the Russian Federation.

WHEREAS, Saitek has used and is using the trademark KASPAROV (the "Trademark") in its business under license from Kasparov;

WHEREAS, Saitek has obtained the following registrations for the Trademark (collectively, the "Registrations"):

WHEREAS, Kasparov desires to acquire all right, title and interest in and to the Registrations together with the goodwill of the business symbolized thereby; and

WHEREAS, the parties desire that this Agreement and the assignments hereunder be made of record in each of the trademark registries where a Registration has been obtained;


