TRADEMARK AND TRADE NAME ASSIGNMENT

THIS TRADEMARK AND TRADE NAME ASSIGNMENT (the "Assignment") is made as of the 24th day of September, 1999, by PINPOINT CORPORATION, a California corporation ("Pinpoint"), with its principal office at 1124 South Lewis Avenue, Tulsa, Oklahoma, transferring and assigning the rights and interests identified below to BRUNSWICK CORPORATION, a Delaware corporation ("Brunswick"), with its principal office at 1 Northfield Court, Lake Forest, Illinois.

WHEREAS, Pinpoint and Brunswick are parties to that certain Asset Purchase Agreement, dated September 24, 1999, pursuant to which Pinpoint has agreed to sell and Brunswick has agreed to purchase certain Assets (as defined in the Asset Purchase Agreement) including, without limitation, United States Trademark Registration No. 2,094,140 (the "Mark") and the goodwill of the business associated therewith; and

WHEREAS, Brunswick wishes to acquire Pinpoint's entire right, title and interest in and to the referenced Mark, United States Trademark Registration 2,094,140, and together with the goodwill of the business associated with the Mark;


NOW THEREFORE, in accordance with the terms of, and for the good and valuable consideration set forth in the referenced Asset Purchase Agreement, the receipt of which is hereby acknowledged, Pinpoint does hereby sell and assign to Brunswick all the right, title and interest Pinpoint has or may have in the Mark, United States Trademark Registration 2,094,140,

and in any and all other marks or names owned or used by Pinpoint or in which Pinpoint otherwise has any ownership interest and which include the listed term of said Mark alone or in combination with other words, figures, designs or indicia, including any rights, title and interest as service marks, trademarks, trade names and all common law rights connected therewith, together with the goodwill of the business associated with the Mark or any such other marks or names that have been used and/or registered and all claims and causes of action relating to infringement of said Mark or said other marks or name.

Pinpoint will assist in obtaining or providing any further documents which may be required to confirm chain of title thereto.
