

ARTICLES OF INCORPORATION
OF
JOHNSON TRAILER CO.



The undersigned incorporator hereby adopts the following articles of incorporation for the purpose of forming a corporation (the "corporation") under the Wisconsin Business Corporation Law, chapter 180 of the Wisconsin Statutes ("chapter 180").

ARTICLE 1
Name

The name of the corporation is JOHNSON TRAILER CO.

ARTICLE 2
Authorized Shares

The aggregate number of shares that the corporation shall have authority to issue is 9,000. The corporation's authorized shares shall consist of one class only and shall be designated as common stock ("common stock"). Each share of common stock shall have no par value.

ARTICLE 3
Registered Office and Registered Agent
