

Pursuant to the provisions of ORS 57.370 of the Oregon Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment:

1. Prior to amendment, the name of the corporation was Pendleton Woolen Mills.
2. The following amendment to the Articles of Incorporation was adopted by the stockholders of the corporation entitled to vote thereon on April 5, 1972, in the manner prescribed by the Oregon Business Corporation Act:

RESOLVED, That ARTICLE I of this corporation's Articles of Incorporation be, and the same hereby is, amended to read as follows:

"ARTICLE I

The name of the corporation is PENDLETON WOOLEN MILLS, INC., and its duration shall be perpetual."

3. The number of shares of the corporation outstanding at the time of such adoption was 28,000, the number of shares voted for such amendment was 28,000; and the number of shares voted against such amendment was none.
4. Such amendment does not provide for an exchange, reclassification or cancellation of issued shares, nor does it affect a change in the amount of stated capital.
