## RELEASE OF SECURITY INTEREST

This Release granted on this 26 day of October, 1999, by BANKERS TRUST COMPANY, as Collateral Agent ("Collateral Agent"), to Corporate Express, Inc., a Colorado corporation, and CEX Holdings, Inc., a Colorado corporation, CEX Holdings, Inc. and Corporate Express, Inc. hereinafter referred to collectively as the "Assignors"), as follows:

### W I T N E S S E T H

WHEREAS, the Assignors have heretofore granted to the Collateral Agent a security interest in certain U.S. trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Marks") to secure the Guaranteed Obligations (as defined in the Security Agreement, dated April 17, 1998, between the Collateral Agent and the Assignors (the "Security Agreement")); and

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Marks to the Assignor and to dissolve any and all Liens and encumbrances respecting the Marks shown on the attached Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby releases, discharges, quit claims and relinquishes unto the Assignors any and all right, title and interest in and to the Marks, and more particularly, (i) the security interest in the trademarks, trademark registrations and trademark applications as set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Uniform Commercial Code as in effect in the State of New York on the \_\_\_th day of October, 1999 or under other relevant law) and products of the Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) all causes of action arising prior to the \_\_\_th day of October, 1999 for infringement of any of the Marks or unfair competition regarding the same, and granted to Collateral Agent by the Assignors by the Security Agreement, which Assignment was duly

recorded on 1<sup>st</sup> day of May, 1998 at Trademark Reel no. 1727 and Frame no. 0365 in the United States Patent and Trademark Office.




