

THIS ASSIGNMENT OF TRADEMARKS is made and entered into this 5th day of January, 1994 by and between Vista Lite Delaware, Inc., a Delaware corporation ("Assignor") and a wholly-owned subsidiary of VistaLite, Inc., a Pennsylvania corporation ("Parent"), having a principal place of business at 2950 Old Tree Drive, Lancaster, PA 17603 and Bell Sports, Inc., a California corporation, having a principal place of business at Route 136E, P.O. 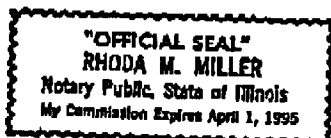

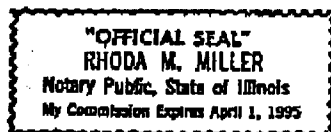


