KOH-I-NOOR INC., a corporation organized under the laws of the State of New Jersey, pursuant to the provisions of Section 907 of the Business Corporation Law of the State of New York hereby certifies as follows:

FIRST: The Board of Directors of KOH-I-NOOR INC. has adopted a plan of merger setting forth the terms and conditions of merging M. GRUMBACHER, INC. (the subsidiary corporation) into KOH-I-NOOR INC. (the surviving corporation).

SECOND: The merger herein certified is permitted by the laws of the jurisdiction of incorporation of Koh-I-Noor Inc. and is in compliance with said laws.

THIRD: The name of the subsidiary corporation to be merged, the certificate of incorporation of which was filed by the Department of State on January 31, 1947, is M. GRUMBACHER, INC. The name under which said corporation was formed is S. Grumbacher, Inc.

FOURTH: The name of the surviving corporation, which was organized under the laws of the State of New Jersey, on December 27, 1937, is KOH-I-NOOR INC. The name under which said corporation was formed is L. & C. Hardtmuth, Inc. No Application for Authority in the State of New York of said corporation to transact business as a foreign corporation therein was filed by the Department of State of the State of New York, and it is not to do business in the State of New York until an Application for Authority shall have been filed by the Department of State of the State of New York.

FIFTH: The designation and number of outstanding shares of each class of M. Grumbacher, Inc., all of which are owned by Koh-I-Noor Inc., as set forth in the plan of merger, are as follows:



1. The name of the subsidiary corporation, which is a business corporation organized under the laws of the State of New York, is **M. GRUMBACHER, INC.** The name under which said corporation was formed is **S. Grumbacher, Inc.**

2. The name of the parent corporation, which is a business corporation organized under the laws of the State of New Jersey, is **KOH-I-NOOR INC.** The name under which said corporation was formed is **L. & C. Hardtmuth, Inc.**

3. The number of outstanding shares of **M. GRUMBACHER, INC.**, all of which are owned by **KOH-I-NOOR INC.**, is 1 share of Common Stock, par value \$0.01 per share.

2. The number of outstanding shares of M. GRUMBACHER, INC., all of which are owned by KOH-I-NOOR INC., is 1 share of Common Stock, par value \$0.01 per share.
3. The separate existence of M. GRUMBACHER, INC., shall cease upon the effective date of the merger pursuant to the provisions of the New York Business Corporation Law; and KOH-I-NOOR INC. shall continue its existence as the surviving corporation pursuant to the provisions of the New Jersey Business Corporation Act.
4. The issued shares of M. GRUMBACHER, INC. shall not be converted in any manner, but each said share which is issued as of the effective date of the merger shall be surrendered and extinguished.
5. The issued shares of KOH-I-NOOR INC. shall not be converted in any manner, but each said share which is issued as of the effective date of the merger shall continue to represent one issued share of KOH-I-NOOR INC.
6. The Board of Directors and the proper officers of KOH-I-NOOR INC. are hereby authorized, empowered, and directed to do any and all acts and things, and to make, execute, deliver, file, and/or record any and all instruments, papers, and documents which shall be or become necessary, proper, or convenient to carry out or put into effect any of the provisions of this Plan of Merger or of the merger herein provided for.
7. The effective date of the merger shall be the 1st day of January, 1997."
5. Neither the certificate of incorporation of KOH-I-NOOR INC. nor the certificate of incorporation of M. GRUMBACHER, INC. requires the approval of its shareholders to authorize the merger herein certified.
6. The applicable provisions of the laws of the State of New York relating to the merger of M. GRUMBACHER, INC. into KOH-I-NOOR INC. will have been complied with upon compliance with any of the filing and recording requirements thereof.
7. KOH-I-NOOR INC. will continue its existence as the surviving corporation pursuant to the provisions of the New Jersey Business Corporation Act.
