

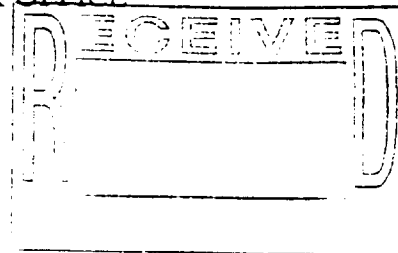



"The name of this corporation is CollegeNET, Inc."


