SECURITY INTEREST RELEASE

AMBI Inc., having an office at 4 Manhattanville Road, Purchase, NY 10577 (the "Pledgor") and STATE STREET BANK AND TRUST COMPANY, having an office at 225 Franklin Street, Boston MA 02110 ("STATE STREET") entered into an Intellectual Property Security Agreement dated as of August 11, 1997 and an Amended and Restated Intellectual Property Security Agreement dated as of January 21, 1999 (collectively, the "Security Agreement"). Citizens Bank of Massachusetts, having an office at 100 Summer Street, Boston, MA 02110 has succeeded to the interests of STATE STREET under the Security Agreement and is referred to herein as the "Pledgee".

AGREEMENT
