

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

IBJ WHITEHALL BANK & TRUST COMPANY

VISTA INFORMATION SOLUTIONS INC.

1. Reference is made to that certain **CREDIT AGREEMENT** (the "Credit Agreement") and certain Loan Documents (as defined in the Credit Agreement) dated as of June 29, 1999 entered into by and between **VISTA INFORMATION SOLUTIONS INC.**, a Delaware corporation ("Borrower"), and **IBJ WHITEHALL BANK & TRUST COMPANY** ("Lender").

2. Pursuant to the Credit Agreement and Loan Documents, Borrower granted to Lender a security interest (the "Security Interest") in each of the trademarks, including the registrations thereof, set forth in Exhibit A attached hereto (collectively, the "Trademarks"), which Trademarks are registered in, or for which applications for registration have been filed in, the United States Patent and Trademark Office (the "PTO").

3. In connection with the Security Interest, a Notice of Security Interest was recorded with the United States Patent and Trademark Office on September 8, 1999 in Reel No. 001925 and Frame No. 0520.

4. Borrower and Lender desire to complete the records of the PTO by recording the termination and release of the Security Interest in order to fully terminate, release and restore to Borrower any and all of Lender's right, title and interest in, to and under the Trademarks and goodwill associated herewith and to fully dissolve any and all of Lender's liens, encumbrances and security interest thereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby agrees as follows:

Lender hereby terminates the Security Interest and releases, discharges, quit claims and relinquishes unto Borrower any and all right, title and interest in, to and under the Trademarks and the goodwill associated therewith.


