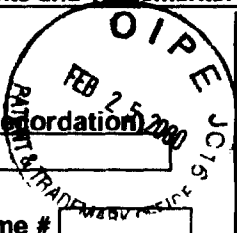

I.


