## TRADEMARK ASSIGNMENT

**THIS TRADEMARK ASSIGNMENT** is made and entered into this 22nd day of November, 1999, by and between **W.S. TYLER, INCORPORATED**, an Ohio corporation ("**Assignor**"), and **NORDBERG TRANSCO INC.**, a Delaware corporation ("**Assignee**").

**WHEREAS**, pursuant to an Agreement and Plan of Reorganization dated as of October 11, 1999 (as amended, restated or otherwise modified as of the date hereof, the "**Plan of Reorganization**") by and among Assignor, Assignee, Capricorn Investors, L.P., a Delaware limited partnership, Nordberg, Inc., a Delaware corporation and Metso Oyj, a Finish corporation, Assignor has agreed to transfer and assign to Assignee and Assignee has agreed to accept from Assignor, upon the terms and conditions set forth in the Plan of Reorganization, certain trademark registrations and applications for registration, as listed in Exhibit 1, which is attached hereto and incorporated by reference herein (hereinafter collectively the "**Trademarks**") together with the goodwill associated therewith;

**NOW, THEREFORE**, in consideration of the foregoing recitals and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, transfers and conveys to Assignee the entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith.

This Trademark Assignment is intended solely to benefit the parties hereto and shall not create any liabilities to any other parties or expand any liabilities to any other parties.

This Trademark Assignment is subject in all respects to the terms and conditions of the Plan of Reorganization. Nothing contained in this Trademark Assignment shall be deemed to supersede any of the covenants, agreements, representations or warranties of Assignor or Assignee contained in the Plan of Reorganization.




