**PARTIAL RELEASE OF SECURITY INTEREST IN  
TRADEMARK AND TRADEMARK APPLICATION**

This Partial Release of Security Interest in Trademark and Trademark Application is made effective as of November 1, 1998 by IPM, Inc., a Delaware corporation with a place of business at 1 Owens Corning Parkway, Toledo, Ohio 43659 (the "Secured Party").
