DISCHARGE/RELEASE OF INTEREST

TO: Microplay Entertainment & Video Centres Inc. ("Microplay")
AND TO: The Officers and Directors thereof
AND TO: Oscar Wald, in his capacity as agent appointed by Victoria L. Bradburn in respect of the property, assets and undertaking of 2950863 Canada Inc. (the "Company")

WHEREAS the Company granted an interest in and to all of the Company's property, assets and undertaking, including US trademark registration nos. 2,024,819 and 2,024,820 (the "Trademarks"), to TCE Capital Corporation ("TCE");

AND WHEREAS pursuant to an assignment agreement made as of the 3rd day of November, 1998, TCE assigned all of the indebtedness, liabilities and obligations of the Company, together with the security held therefor, to Victoria L. Bradburn (the "Secured Creditor");

AND WHEREAS pursuant to an appointment made as of the 17th day of January, 1999, the Secured Creditor appointed Oscar Wald, trustee in bankruptcy, as agent in respect of all of the Company's property, assets and undertaking including the Trademarks;

AND WHEREAS pursuant to a bill of sale made as of the 22nd day of January, 1999, Oscar Wald conveyed his and Bradburn's interest in and to the Trademarks to Microplay.

NOW THEREFORE FOR VALUE RECEIVED, the receipt and sufficiency of which are hereby acknowledged, the Secured Creditor hereby:

1. releases, in full, any interest the Secured Creditor holds in the Trademarks; and
2. undertakes to execute and deliver all such other discharges, termination statements, financing change statements and documents as Microplay may reasonable require to discharge fully the security interest held by the Secured Creditor in the Trademarks.
