**TRADE NAME AND TRADEMARK ASSIGNMENT**

THIS TRADE NAME AND TRADEMARK ASSIGNMENT is dated as of the 20 day of July, 1998, by and between COURTAULDS COATINGS INC., <sup>n/k/a International Paint Inc.</sup> a Kentucky corporation ("Courtaulds") and SPRAYLAT CORPORATION, a New York corporation ("Spraylat").

**RECITALS:**

A. On July 3, 1998 Courtaulds and Spraylat entered into a Master Exchange Agreement ("Exchange Agreement") pursuant to which certain assets of each are to be exchanged for assets of the other.

B. As part of the exchange, Courtaulds is assigning certain trade names and trademarks to Spraylat, as set forth herein.

TO HAVE AND TO HOLD all of the aforesaid trade names and trademarks hereby conveyed, assigned and transferred unto Spraylat to and for the use of Spraylat, its successors and assigns, forever.
