Sapient Corporation, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

FIRST: That the Corporation was incorporated on the 18th day of September, 1991, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the capital stock of Studio Archetype, Inc., a corporation incorporated on the 7th day of March, 1990 pursuant to the California Corporations Code.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted by written consent dated June 30 1999, determined to merge into itself Studio Archetype, Inc. on the conditions set forth in such resolutions:

RESOLVED: That, pursuant to Section 253 of the General Corporation Law of the State of Delaware, the Corporation is hereby authorized to merge Studio Archetype, Inc., a California corporation which is a wholly owned subsidiary of the Corporation, into the Corporation and to assume all of such subsidiary's liabilities and obligations;

FURTHER

RESOLVED: That any co-Chief Executive Officer, the Chief Financial Officer and the Secretary of the Corporation be, and each of them acting singly hereby is, authorized to execute a Certificate of Ownership and Merger setting forth a copy of the resolution to merge Studio

Archetype, Inc. into the Corporation and to assume said subsidiary's liabilities and obligations and the date of adoption thereof and to cause the same to be filed with the Secretary of State of Delaware and a certified copy thereof to be recorded in the office of the Recorder of Deeds of New Castle County, and to take all such other actions and to execute all such other instruments and agreements as they or any of them may deem appropriate to effect such merger;

FURTHER

RESOLVED: That the merger of Studio Archetype, Inc. into the Corporation shall be effective upon the filing of a Certificate of Ownership and Merger with the Secretary of State of Delaware.
