WHEREAS, Assignor desires to assign to the Assignee, and Assignee wishes to accept all rights, titles and interest in and to the Marks.

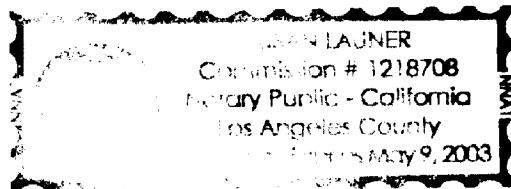
