THIS RELEASE (Trademarks, Trademark Registrations, Trademark Applications and Trademark Licenses) is given on this 1st day of February, 2000, by Morgan Guaranty Trust Company of New York, as Collateral Agent, ("Assignor"), to Vlastic Farms, Inc. ("Assignee"), as follows:

WHEREAS, a Security Agreement, dated as of September 30, 1998 (the "Security Agreement"), was entered into among Vlastic Foods International Inc., the Subsidiary Guarantors party thereto (including Assignee and VF Brands, Inc. ("Brands")) and Assignor (capitalized terms used herein and not otherwise defined herein shall have the meanings set forth in the Security Agreement);

WHEREAS, pursuant to the Security Agreement, Assignee and Assignor entered into a Trademark Security Agreement dated as of October 7, 1998 (the "Assignee Trademark Security Agreement");

WHEREAS, pursuant to the Security Agreement, Brands and Assignor entered into a Trademark Security Agreement dated as of October 7, 1998 (the "Brands Trademark Security Agreement");

WHEREAS, pursuant to the Assignee Trademark Security Agreement, Assignee granted a continuing security interest in all its right, title and interest in, to and under the Trademark Collateral (as defined in the Assignee Trademark Security Agreement);

WHEREAS, pursuant to the Brands Trademark Security Agreement, Brands granted a continuing security interest in all its right, title and interest in, to and under the Trademark Collateral (as defined in the Brands Trademark Security Agreement);

WHEREAS, the Brands Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 30, 1998, at Reel 1833, Frame 0786;

WHEREAS, pursuant to an Assignment, dated December 23, 1999, Brands assigned and transferred to Assignee all right, title and interest in and to those Trademarks listed on Schedule A hereto; and
