ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
OF  
LYKES PASCO, INC.

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following articles of incorporation:

FIRST: Amendment adopted: Article I of the Articles of Incorporation is being amended to change the name which will hereby read as follows:

"ARTICLE I
