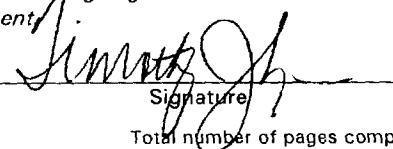

Article III The amendment was adopted by the shareholders or directors in the manner prescribed by law on 12-31 1997.

Article IV The number of shares outstanding at the time of the adoption was 80,000; the number of shares entitled to vote thereon was 80,000. 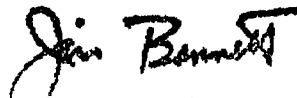
