ARTICLES OF AMENDMENT

Worldnetpress, Inc., a Maryland close corporation, having its principal office at 10919 McCormick Road, Hunt Valley, Maryland 21031 (hereinafter called the "Corporation") hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The Charter of the Corporation is hereby amended by striking out Article I in its entirety and inserting in lieu thereof the following:

ARTICLE I

NAME

The name of the corporation (which is hereinafter called the "Corporation") is: Versient, Inc. *um*

SECOND: The Charter of the Corporation is hereby further amended by striking out Article IV in its entirety and inserting in lieu thereof the following:

ARTICLE IV  
AUTHORIZED STOCK

The total number of shares of stock of all classes which the corporation has authority to issue is six million seven hundred and fifty thousand (6,750,000) shares, \$0.01 par value per share, all of which shares are of one class and are designated Common Stock. The aggregate par value of all shares of stock of the Corporation is \$67,500.

THIRD: At a meeting duly called and held on January 31, 2000, the Board of Directors of the Corporation adopted a resolution declaring the amendment advisable and directing the matter to be submitted to the sole stockholder of the Corporation for approval. The sole stockholder approved the amendment of the Charter by unanimous written consent dated January 31, 2000.

FOURTH: These Articles of Amendment increase the authorized stock of the Corporation and the aggregate par value of such authorized stock. Immediately before the amendment, the total number of shares of stock of all classes which the Corporation had authority to issue was three million (3,000,000) shares, \$0.01 par value per share, all of which shares were of one class and designated Common Stock. The aggregate par value of all shares of stock of the Corporation with par value was \$30,000. As amended, the total number of shares of stock of all classes which the Corporation has authority to issue is six million seven hundred and fifty thousand (6,750,000) shares, \$0.01 par value per share, all of which shares are of one class
