ASSIGNMENT OF TRADEMARK & REGISTRATION

WHEREAS, DINORALL CORPORATION, a Florida corporation (hereinafter DINORALL) having a principal address of 2031 N.W. 79th Avenue, Miami, Florida 33122, adopted the mark "KELYX," as well as the mark "KELYX and Design" for computer parts, namely, computer disc drives, keyboards, video display terminals, and other internal parts for a computer, and further, whereas DINORALL has, either directly or indirectly, continuously used and is using said marks in connection with said goods in the United States, as well as in certain foreign countries; and

WHEREAS, SR AMERICA LLC., a limited liability corporation of the State of Florida having a principal place of business at 6800 Veronese Street, Coral Gables, Florida 33146 desires to purchase and own the aforesaid trademarks in the U.S. and foreign countries, including the aforesaid U.S. Trademark Registration and any other registrations and/or pending applications therefor, together with all rights and interests therein and including the goodwill associated therewith.

NOW, THEREFORE, in exchange for Ten U.S. Dollars (\$10.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, the aforesaid DINORALL, by these presents, does hereby assign, transfer and set over unto the aforesaid SR AMERICA LLC., the full and exclusive right, title and interest in and to the mark "KELYX" and also to the mark "KELYX & Design," together with U.S. Trademark Registration No. 1,796,912 therefor and any other registrations and/or pending applications therefor in this or a foreign country, for its own use and benefit in the territory of the United States of America and extending to all foreign countries, and for that of its successors and assigns to the full end of the term for which said U.S. Trademark Registration has and/or other registrations have been granted, and any and all renewals thereof, as fully and entirely as the same would have been held and enjoyed by the aforesaid DINORALL, had this Assignment not been made.
