1. We are the duly elected President and Secretary of Slam Dunk, Inc., a California corporation.

2. Article I of the Amended and Restated Articles of Incorporation of this corporation is amended to read as follows:

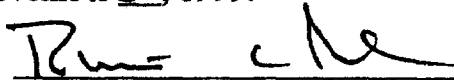
“The name of this corporation is Slam Dunk Networks, Inc.”

3. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the board of directors.

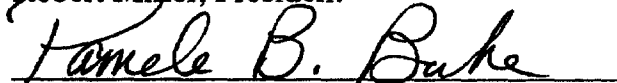
4. The foregoing amendment of the Amended and Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the Corporations Code. The total number of outstanding shares of the corporation is 1,500,000 shares of Common Stock and 2,500,000 shares of Series A Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage voted required was more than 50% of the Common Stock and Preferred Stock.
