**CERTIFICATE OF AMENDMENT  
OF  
ARTICLES OF INCORPORATION**

Gerald H. Parrick and Frank R. Robles certify that:

1. They are the Chief Executive Officer and Secretary, respectively, of NanoSpace, Inc., a California corporation.

2. ARTICLE I of the Articles of Incorporation of this corporation is amended to read as follows:

“The name of this corporation is Yipes Communications, Inc.”

3. The foregoing Amendment of Articles of Incorporation has been duly approved by the Board of Directors.

4. The foregoing Amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation is 5,702,000 shares of Common Stock and 8,739,770 shares of Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50% of all outstanding shares.
