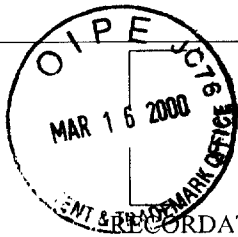

ARTICLES OF AMENDMENT

OF

NEXTLINX CORPORATION

NextLinx Corporation, a Maryland corporation (hereinafter called the "Corporation"), hereby certifies to the State Department of Assessments and Taxation of Maryland that:

FIRST: The charter of the Corporation is hereby amended by deleting Article Second in its entirety, and inserting in lieu thereof the following:

"SECOND: The name of the corporation (which is hereinafter called the "Corporation") is:

NEXTLINX HOLDING CORPORATION"

SECOND: The Board of Directors of the Corporation, by unanimous written consent pursuant to Section 2-408(c) of the Maryland General Corporation Law signed by all the members thereof and filed with the minutes of proceedings of the Board, duly advised the foregoing amendment and directed that it be submitted for action thereon by the stockholders.

THIRD: By unanimous written consent, pursuant to Section 2-505 of the Maryland General Corporation Law, signed by the stockholders of the Corporation and filed with the records of the stockholders' meetings, the stockholders of the Corporation duly approved such amendment.

FOURTH: The amendment of the charter of the Corporation as hereinabove set forth has been duly advised by the Board of Directors and approved by the stockholders of the Corporation.

IN WITNESS WHEREOF, NextLinx Corporation, has caused these Articles of Amendment to be signed in its name and on its behalf by its President and attested to by its Secretary on this 16<sup>th</sup> day of NOVEMBER, 1999, and the undersigned President of NextLinx Corporation acknowledges these Articles of Amendment to be the act of the Corporation and that, to the best of his knowledge, information and belief, the matters and facts set forth in these Articles of Amendment with respect to its authorization and approval are true in all material respects and that this statement is made under the penalties for perjury.
