ASSIGNMENT OF SERVICEMARKS

WHEREAS, Cambridge Technology Partners (Massachusetts), Inc. (a.k.a. Cambridge Technology Partners, Inc.) In connection with such assignment, CTP shall execute such further documents as EW may request in order to effect such assignment.


