CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION

The undersigned, being the duly elected Assistant Vice President, Assistant Secretary of SunGard MIS Inc., a Delaware corporation (the "Corporation") certifies that:

1. The resolutions set forth below (the "Resolutions") regarding the amendment to the Certificate of Incorporation of the Corporation, were duly adopted in accordance with the applicable provisions of Section 242 and 228 of the General Corporation Law of the State of Delaware by the Board of Directors and the Sole Stockholder of the Corporation by unanimous written consent dated January 9, 1998.

RESOLVED, that the Certificate of Incorporation of SunGard MIS Inc. be amended by changing the First Article thereof so that, as amended, said Article shall be read as follows:

"The name of the corporation is SunGard Insurance Systems Inc."
