**ASSIGNMENT OF U.S. SERVICE MARKS**

WHEREAS, Americar Rental System, Inc. (hereinafter "AMERICAR"), a Delaware corporation having a principal place of business at 5400 S. Bay Road, North Syracuse, New York 13212 has adopted, used, and is using in its business the service marks "AMERICAN INTERNATIONAL" and "AI AMERICAN INTERNATIONAL RENT-A-CAR and Design" (hereinafter collectively referred to as "THE MARKS");

WHEREAS, THE MARKS are the subjects of U.S. service mark applications owned by AMERICAR having Serial Nos. 75/128,333 and 75/128,332, respectively, covering automobile renting and leasing services and limousine services;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, AMERICAR hereby assigns and transfers to AIG, and its successors in interest, the entire right, title, and interest in and to THE MARKS and the U.S. service mark applications having Serial Nos. 75/128,333 and 75/128,332, together with the associated goodwill of the business in connection therewith, including all common-law and other rights in THE MARKS, all claims, demands, and causes of actions, both at law and in equity, that AMERICAR may have, or may hereinafter acquire, on account of any infringement of THE MARKS, and does hereby empower AIG, and its successors in interest, to sue for and collect the same, to its and their own absolute use.

IN WITNESS WHEREOF, the undersigned, being duly authorized and acting on behalf of AMERICAR, does hereby execute this agreement to take effect on the date noted below.
