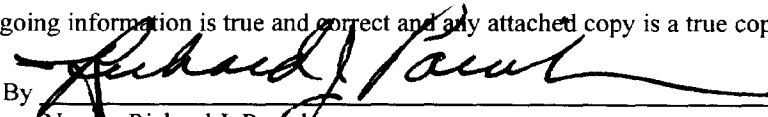

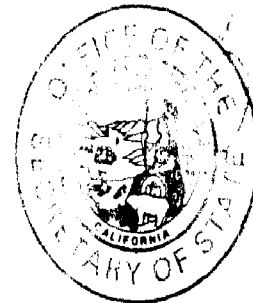

Jeffrey Thermond, Chief Executive Officer and President, and David A. Dull, Vice President and Secretary of Epigram, Inc., a corporation duly organized and existing under the laws of the State of California (the "Corporation"), do hereby certify that:

1. They are the duly elected, acting and qualified President and Chief Executive Officer, and Vice President and Secretary, respectively, of the Corporation.

2. The name of the corporation is Epigram, Inc.

3. Article One of the Articles of Incorporation of this corporation is amended to read as follows:

"The name of the corporation is Broadcom HomeNetworking, Inc."

4. The foregoing amendment has been duly approved by the Board of Directors in accordance with the California Corporations Code.

5. The foregoing amendment has been duly approved by the required vote of shareholders in accordance with California Corporations Code Section 902. There is only one authorized class of shares, consisting of 10,000 shares of Common Stock, and the total number of issued and outstanding shares entitled to vote is 10,000. Approval of the foregoing amendment by the holders of at least a majority of the outstanding shares of Common Stock was required. The percentage of the outstanding shares of the Common Stock equaled or exceeded the vote required.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
