TRADEMARK ASSIGNMENT

WHEREAS, on August 17, 1998, an officer of American Tape Co., a Delaware corporation, whose address is 317 Kendall Avenue, Marysville, Michigan 48040-2440 (“American Tape”) executed an Assignment of certain trademarks to be assigned to Intertape Polymer Inc., a Canadian corporation, whose address is 110E Montee de Liesse St-Laurent, Montreal, PQ H4T 1N4, Canada (“Intertape”), and said Assignment was recorded in the public records of the United States Patent and Trademark Office on September 8, 1998 as document 100823269 (the “1998 Assignment”);

WHEREAS, the 1998 Assignment covered certain trademarks set forth in attached Exhibit “A” (the “Marks”);

WHEREAS, the 1998 Assignment was filed and recorded erroneously, as neither of the parties intended for the Marks to be assigned or for the ownership of the trademarks to be conveyed to Intertape;

WHEREAS, no consideration was exchanged between the parties for the 1998 Assignment;

WHEREAS, both parties have consistently considered and treated the Marks as being owned by American Tape and not by Intertape;

WHEREAS, both parties desire that the 1998 Assignment be rescinded and that the ownership of the Marks vest in American Tape; and

WHEREAS, Intertape desires to convey, assign, sell, and transfer any and all of its right, title and interest in the trademarks listed in attached Exhibit “A”, and American Tape

desires to effectuate this conveyance.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Intertape hereby sells, assigns and transfers to American Tape any and all rights, title and interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and the Registrations thereof.
