The President and Secretary of the Company hereby is authorized and directed for, on behalf and in the name of the Company to execute and deliver all other documents and instruments contemplated by the Merger Agreement, with each of such documents and instruments to be in such form and to contain such provisions as the President and Secretary of the Company shall approve and his signature appearing thereon shall constitute conclusive evidence of his approval thereof.

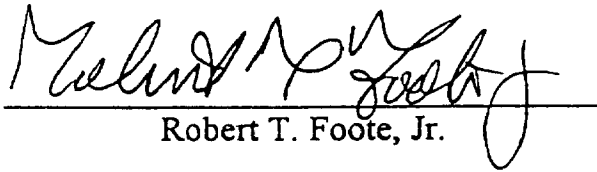

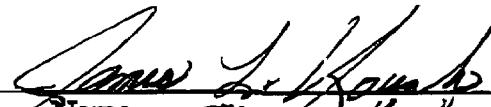
