

- Article I of the Amended and Restated Articles of Incorporation of said П. corporation is amended to read in its entirety as follows:

#### ARTICLE I

The name of this Corporation is EdVISION.com Corporation.

The foregoing amendment to the Amended and Restated Articles of Incorporation of said corporation has been duly approved by the board of directors of said corporation.
