

SECOND RESTATED ARTICLES OF INCORPORATION

1. Article 1 of the Corporation's Second Restated Articles of Incorporation is hereby amended, in its entirety to read as follows:

Article 1.

The name of the corporation is iMove, Inc.

2. Section 2.1 of Article 2 of the Corporation's Second Restated Articles of Incorporation is hereby amended in its entirety as follows:

Article 2.

2.1 **Authorized Shares.** The aggregate number of shares which the Corporation shall have authority to issue is 30,000,000 shares of common stock, \$0.001 par value ("Common Stock"), and 15,000,000 shares of preferred stock, \$0.001 par value ("Preferred Stock").
