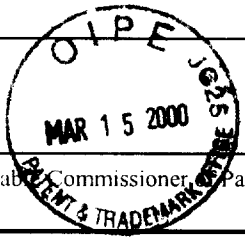

Pursuant to the provisions of Section 1309 of the Business Corporation Law, the undersigned corporation hereby makes the following statements for the purpose of amending its Application for Authority.

1. The name of the corporation as it appears on the index of names of existing domestic and authorized foreign corporations of any type or kind in the Department of State, Division of Corporations is PublicDataSystems, Inc.
2. It is Incorporated under the laws of the State of Delaware.
3. The date it was authorized to do business in New York was March 11, 1999.
